BOROUGH OF KUTZTOWN COMMUNITY DEVELOPMENT AND PUBLIC SAFETY COMMITTEE MEETING MINUTES OF OCTOBER 14, 2025

PUBLIC COMMENTS:

Mr. Donald Sheetz, Ms. Jane Bennett, along with several neighbors of College Garden Drive, mentioned that the property at 583 College Garden Drive has been overgrown severely, adding that the residents have made several complaints, and they are wondering if any action has been taken against the owner. Dr. Mace mentioned that according to Mr. Young's report, the owner of 583 College Garden Drive has been issued two notices of violation, and he has called the owner twice, the last being this date at noon. Mr. Snyder mentioned that he was approached by a contact at the Kutztown Tavern complaining that their customers are receiving parking tickets while they are eating lunch. Chief Clery mentioned that the first hour is free to park in the municipal lot. Mr. Eric Boyer reviewed the process for using the parking meter at the municipal parking lot.

There was a brief discussion regarding the "no stopping, no standing, no parking" sign and the possibility of changing one or all of them to 15 minute parking. There was a brief discussion regarding the sign.

Mr. Engelhardt mentioned that Borough Council members requested that parking be enforced due to Kutztown residents complaining about parking not being enforced. He added that he believes a good job is being done by parking enforcement.

MAYOR'S REPORT:

Mayor Schlegel reviewed his hours for the month of September with Committee members.

Mr. Kusterer questioned what the process would be to raise the fine for parking in front of a fire hydrant from \$25 to \$50. Dr. Mace mentioned that if there were other updates that would need to be made, they could be "bundled" together to save money.
