# BOROUGH OF KUTZTOWN PUBLIC WORKS COMMITTEE MEETING MINUTES OF January 3, 2024

A regular meeting of the Public Works Committee was held on Wednesday, January 3, 2024 at the Kutztown Municipal Building, 45 Railroad Street.

The meeting was called to order at 7:32 p.m. by Mr. Kevin Snyder, Chairman. Member's present were: Ms. Lisa Ladd-Kidder and Mr. Ed Seyler. Also in attendance: Mr. Gabriel Khalife, Borough Manager; Mr. Brian Bailey, Public Works Superintendent; Mr. Joe Rogosky, P.E. of Great Valley Consultants; Mr. Mike Berger of the Maxatawny Sewer Authority; Mr. Dave Firestone and Mr. Eric Boyer.

#### APPROVAL OF MINUTES

Committee members reviewed the December 5, 2023 minutes.

A motion was made by Ms. Ladd-Kidder and seconded by Mr. Seyler to approve the December 5, 2023 minutes once a correction was made in the Engineering Review to change the storm work total amount of \$66,000.00 listed to \$138,215.00 to reflect the correct amount. The motion passed by unanimous vote.

#### **ENGINEERING REVIEW**

Mr. Rogosky reviewed the ARPA Stormwater Grant for Main St. noting that the Borough was awarded \$135,000.00 to be used to replace the storm line on West Main Street between Constitution Boulevard and Greenwich Street. He informed the committee that this will need to go out on bid.

No action taken.

Mr. Rogosky reviewed payment application No.1 in the amount of \$37,125.00 to CMS for the West Main Street Storm Work.

A motion was made by Mr. Seyler and seconded by Ms. Ladd-Kidder to approve payment application No.1 from CMS in the amount of \$37,125.00 for the work done on West Main Street. The motion passed by unanimous vote.

Mr. Rogosky reviewed final payment application No.2 in the amount of \$108,308.59 to CMS for the West Main Street Storm Work.

A motion was made by Mr. Seyler and seconded by Ms. Ladd-Kidder to approve payment application No.2 from CMS in the amount of \$108,308.59 for the final payment for work done on West Main Street. The motion passed by unanimous vote.

Mr. Rogosky Reviewed the Green Light Go Grant noting that Telco was the lowest bidder at \$111,775.00 and that he recommends that the Borough awards the Traffic Signal Improvement Project bid to Telco Inc. He also asked if the Borough plans to award the bid to Telco that we give them a notice of intent to award them the bid so they can start the process of ordering supplies due to long lead times.

A motion was made by Mr. Seyler and seconded by Ms. Ladd-Kidder to recommend that the council award the Traffic Signal Improvement Project bid to Telco Inc. for \$111,775.00 and to send them a notice of intent to award them the bid so they can start the process of ordering supplies due to long lead times. The motion passed by unanimous vote.

Mr. Rogosky and Mr. Bailey discussed options for the 2024 Paving Contract.

The committee asked that Mr. Rogosky and Mr. Bailey narrow down the list of work and factor the cost of the Green Light Go Grant and the Stormwater Grant against the paving contract budget as well as exploring the option of doing some of the work on the list separate from the paving contract.

Mr. Firestone asked when the handicapped parking sign the he requested for his property at 256 East Walnut would be installed.

Mr. Bailey stated that there was a delay due to questions about if the sign was really needed but that it is back on the job board and that he expects the sign to be installed before January is over.
