After discussions with Mr. Struss and the committee, the committee asked Mr. Rogosky to revise the plans for Keiter Alley to address Mr. Struss's concerns and to meet with Mr. Struss on site to discuss some more potential changes to the plan.

A motion was made by Mr. Seyler and seconded by Ms. Ladd-Kidder to approve Payment No. in the amount of \$260,617.93 from Kinsley for the Public Works and Administration building project. The motion passed by unanimous vote.

Mr. Bailey informed the committee that the hitching post at north park is being used. **No action taken.**

Mr. Schmoyer informed the committee that the trees have been planted in the Main Street Park. **No action taken.**

Mr. Schmoyer informed the committee that the KASD is looking to possibly enter into and agreement with the Borough to do upgrades to the softball field in the park.

The committee asked Mr. Schmoyer and Mr. Bailey to work out the details with the KASD and report back to the committee.
