# BOROUGH OF KUTZTOWN WATER/WASTEWATER COMMITTEE MEETING MINUTES OF APRIL 12, 2023

## **APPROVAL OF MINUTES**

The March 8, 2023, meeting minutes were reviewed by members. Motion by Ms. Ladd-Kidder and seconded by Dr. Mace to approve the March 8, 2023, minutes as written. The motion passed by unanimous vote.

#### **Wentz Street Grant Discussion**

Mr. Smith noted to the Committee that the grant application was not awarded. After a discussion the Committee requested Mr. Smith to contact HRG to get an updated cost estimate to tie in the line from Greenwich Street to the end of the line.

# **Discuss on the PADEP Inspection Follow-Up Report**

Mr. Smith explained that his department followed through on all the findings in the PADEP report, and indicated to the PADEP representative that he submitted the paperwork, which in turn, they concurred and indicated it is on their desk for process. Mr. Smith is awaiting their response to what was submitted.

## **Leak Update**

Mr. Smith stated that the Water Department repaired a number of water leaks, via leak detection and corrections and repairs, which resulted in the January water loss rate of 67% decreasing to 19%.

# **Discuss the New PADEP PFAS MCL Rule**

After a brief discussion and update from Mr. Smith that if the Borough follows through with the testing now, we will need to undertake the cost to address any issues. If the Committee changes course and deferred the previous action the Borough can wait until January 2024 to begin testing. The Committee recommended that Mr. Smith wait to defer the costs.

Mr. Ladd-Kidder inquired about the enforcement side of the recent Wastewater ordinance passed. Mr. Miller indicated that enforcement is incorporated into the ordinance and will be pursued when violations are identified.
