Approval of Minutes of the April 12, 2023, meeting were reviewed by members. Motion by Mr. Vanek and seconded by Mrs. Fulton to accept the April 12, 2023, minutes as written. The motion passed by unanimous vote.

Review of the YTD Financial Statements and 2022 Audit.

Mr. Khalife reviewed the 2022 year to date financial report and indicated that the December transfer did not get posted until January 17, 2023, so the December 2022 'revenue and expense' were not included in the 2022 fiscal year. Also in 2022 KMA expensed our \$75,000 contribution to the Borough for the sludge tank rehabilitation project. Mr. Khalife reviewed the 2022 audit and noted the KMA's fund balance increased. Mr. Khalife reviewed the 2023 year to date and noted the new tier rate system implemented has been working well and to date.

Mr. Khalife provided an update on the St. Lukes Municipal Agreement:

Mr. Khalife reviewed the status of the St. Lukes water line, and it was completed and that our attoney has inidcated that KMA Board can take action to authorize the Board Chair to eneter into the maintenance agreement with the FANELLI GROUP PROPERTIES, LLC upon our enginer's revew and certification of the project's completion. Motion by Mr. Vanek and seconded by Mrs. Fulton to authorize the Chair to enter into the agreement once KMA's engineer certifies the completion. The motion passed by unanimous vote.
