A regular meeting of the Kutztown Borough Council was called to order at 7:33 p.m. in the Kutztown Train Station, by the President, Mr. Kevin Snyder, with other members of Borough Council present: Mr. Derek Mace, Mr. Edwin Seyler, Ms. Arabel Elliott, Ms. Amanda Raudenbush, and the Mayor, Mr. James Schlegel. Councilman Zebulon Hull was absent. Mr. Keith Mooney, Borough Solicitor; Mr. Gabriel Khalife, Borough Manager/Treasurer; Ms. Andrea Rahn, Assistant Borough Secretary; Mr. Steve Diehl, Electric Superintendent; Police Chief Craig Summers; Patrol Officer Matthew Yerger; Kutztown Community Partnership/Kutztown University Community Liaison Sandy Green; Planning Commission representative Fred Englehardt; AMP representative Paul Beckhusen; visitor Rachel Yerger; and resident Warren Shaub were also present.

Mayor Schlegel read aloud the proposed Resolution awarding the Life Saving Award to Kutztown Borough Police Department Patrol Officer Matthew J. Yerger.

A motion was made by Mr. Mace, seconded by Ms. Raudenbush, Resolved, To adopt the following Resolution:

#### **RESOLUTION NO. 11-2021**

A RESOLUTION OF THE COUNCIL OF THE BOROUGH OF KUTZTOWN, BERKS COUNTY, PENNSYLVANIA TO AFFIRM THE RECOMMENDATION OF THE AWARDS REVIEW BOARD TO AWARD THE LIFE SAVING AWARD TO KUTZTOWN BOROUGH POLICE DEPARTMENT PATROL OFFICER MATTHEW J. YERGER.

WHEREAS, Kutztown Borough Police Department Standard Operating Procedure 2011-04 provides for the recognition of Police Officers who perform their duties in a manner beyond that which is normally expected; and

WHEREAS, the recognition of Police Officers is done by awards; and

WHEREAS, Standard Operating Procedure 2011-4 requires that the Council of the Borough of Kutztown affirm by resolution a recommendation by the Awards Review Board; and

WHEREAS, the Awards Review Board has recommended that Kutztown Borough Police Department Patrol Officer Matthew J. Yerger be awarded the LIFE SAVING AWARD for performing an act in the line of duty. On May 9, 2021, through prompt and alert actions, during an overdose event in which Officer Yerger performed CPR and administered Narcan to an individual who had no pulse and was not breathing. As a direct result of Officer Yerger's actions he saved the life of this individual.

NOW, THEREFORE, BE IT RESOLVED AND IT IS HEREBY RESOLVED by the Council of the Borough of Kutztown to award the LIFE SAVING AWARD to Kutztown Borough Police Department Patrol Officer Matthew J. Yerger.

This Resolution shall become effective on June 15, 2021.

Passed by unanimous vote.

Paul Beckhusen gave a presentation regarding the implementation of an AMP

Peaking Project. He explained that participation would save the Borough on

transmission and capacity costs, and the life expectancy of the project is 25-30 years. He

also noted that a sales contract would need to be adopted and approved to move forward,

and site locations would need to be evaluated.

Regarding the AMP presentation, Mr. Shaub wondered why there is a lack of interest in peak hours. Mr. Seyler responded that the Borough does not use peak rates.

Mr. Shaub also commented that there are a lot things going on in town to worry about besides events.

Because of Council member present and future resignations, Mr. Shaub expressed his concern about the lack of representation in Ward 2. Mr. Mooney stated that Council can request community interest in filling the position(s).

Council members can be appointed to the vacant Committee postions.

Ms. Elliott expressed her appreciation to Chief Summers for updating these

Standard Operating Procedures.

Mr. Mace noted that the Committee members wish to thank Amanda Raudenbush for her great leadership and dedication to the Community Development and Public Safety Committee. She responded that she enjoyed her time on the Committee and that she will miss it.

A motion was made by Mr. Seyler, seconded by Ms. Raudenbush, Resolved, To approve \$60.00 refunds to Destiny Davis and Ashley Young for the accidental pavilion double booking that occurred. Passed by unanimous vote.

A motion was made by Mr. Seyler, seconded by Ms. Raudenbush, Resolved, To approve the 2021 line-painting quote (items 1, 2, 4, 6, 10, 14, and 15), from Berks Traffic, Inc., in the amount of \$10,145.62.00. Passed by unanimous vote.

A motion was made by Mr. Seyler, seconded by Ms. Raudenbush, Resolved, To approve the request, from the Kutztown Area School District's United Way Committee, to have a rubber duck race in the Sacony Creek, on August 28, 2021, from 2:00 p.m. until 3:00 p.m. Passed by unanimous vote.

Off of the agenda, a motion was made by Mr. Seyler, seconded by Ms. Raudenbush, Resolved, To approve the Relay for Life Committee to hang sponsor signs throughout town. Passed by unanimous vote.

Under Personnel Committee, a motion was made by Ms. Elliott, seconded by Mr. Seyler, Resolved, To accept, with huge regret, Amanda Raudenbush's resignation from Borough Council, effective July 1, 2021. Passed by unanimous vote.

A motion was made by Ms. Elliott, seconded by Ms. Raudenbush, Resolved, To ratify the lateral transfer of job duties for Charles Lawson, to Criminal Investigator, at an hourly rate of \$44.96, effective May 3, 2021. Passed by unanimous vote.

A motion was made by Mr. Seyler, seconded by Mr. Mace, Resolved, To reappoint Andrew Arnold, as a member of the Housing License Appeals Board, whose term shall expire on July 1, 2022. Passed by unanimous vote.

A motion was made by Ms. Elliott, seconded by Mr. Mace, Resolved, To appoint Jeffrey Dietrich, as a member of the Borough Planning Commission, whose term shall expire on January 1, 2025. Passed by unanimous vote.

Under Finance and Electric Committee, Mr. Mace noted a potential site for a substation along rail property, which would be supported by Government funding.

Mr. Diehl stated that at least two transformers would be needed in case of power failure.

Under Telecommunications and Information Technologies Committee, there was nothing to report.

Under Water and Wastewater Committee, a motion was made by Mr. Seyler, seconded by Mr. Mace, Resolved, To draft and send a letter to our PA State Senator, Representative and legislators, as well as to the PA State Association of Boroughs, indicating the Borough's opposition to the proposed Senate Bill 597. Passed by unanimous vote.

A motion was made by Mr. Seyler, seconded by Mr. Mace, Resolved, To approve Payment Application No. 1, from DESCCO Design & Construction, Inc., for the 2020

Collection System Rehabilitation Briar Cliff and College Garden Drive Pump Stations Project, in the amount of \$41,814.01. Passed by unanimous vote.

Under Miscellaneous, a motion was made by Mr. Seyler, seconded by Ms. Raudenbush, Resolved, To approve the revised, scaled down Multimodal Transportation Project per the Borough's recent grant award. Passed by unanimous vote.

President Snyder called for an Executive Session at 9:19 p.m. to discuss a personnel matter. The Executive Session ended, and the meeting reconvened at 9:38 p.m. No action was taken.

A motion was made by Mr. Mace, seconded by Mr. Seyler, Resolved, To adjourn the Council meeting upon vote. Passed by unanimous vote. The meeting ended at 9:39 p.m.
