A regular meeting of the Kutztown Borough Council was called to order at
7:31 p.m. in the Kutztown Train Station by the President, Mr. Kevin Snyder, with other
members of Borough Council present: Dr. Derek Mace, Mr. Edwin Seyler, Ms. Lisa
Ladd-Kidder, Mr. George Kusterer, Mr. Frederick Engelhardt, and the Mayor, Mr. James
Schlegel. Mr. Keith Mooney, Borough Solicitor; Mr. Gabriel Khalife, Borough
Manager/Treasurer; Ms. Gina M. Wiand, Borough Secretary/Public Relations and
Marketing Director; Police Chief Mike Clery; Mrs. Sharon Dalickas, Finance
Director/Assistant Treasurer/Acting Assistant Borough Manager; Kutztown Planning
Commission representatives Bob Weller and Joel Seidel; Kutztown Fire and Rescue
representative Todd Evans; Villas at Maxatawny representatives Brian Kobularcik and
Scott Sweigart; and Borough residents Robyn Reinisch, Jeff Dietrich, Julie Stark, Martha
Kuhns, Eric Boyer, Lisa Foreback, Mike Shaw, Andrew Vogel, Christen Taylor,
Katharine Keegan, and Mike Downing were also present.

Mr. Kusterer opened the meeting with a prayer.

Joe Keefe, from Ostergaard Acoustical Associates gave a virtual presentation regarding assistance with a Noise Ordinance.

Mr. Keefe explained that Ostergaard was asked to look at the Borough's draft Noise Ordinance and that they can help figure out what it does and does not do.

Mr. Engelhardt noted that the Borough does not have a comprehensive Noise

Ordinance and asked if Ostergaard has a draft that the Borough can build on and adapt to

its needs.

Mr. Keefe stated that there is an Ordinance from a municipality in New Jersey that could be used as a model.

President Snyder opened the discussion to the public.

Mike Downing asked if the Borough is on better legal footing with Ostergaard than with a lawyer.

Mr. Keefe responded that their involvement would make it scientifically better, but not more lawful and enforceable.

Dr. Mace asked if the parameters would be general or specific, and Mr. Keefe responded that the parameters would not be specific.

Andrew Vogel asked if this would be based on scientific research, and Mr. Keefe responded that it would.

Mr. Engelhardt asked how long the process would take, and Mr. Keefe responded that it could go as fast as the Borough wants it to, depending on its own process.

A motion was made by Mr. Engelhardt, seconded by Dr. Mace, Resolved, To approve the Ostergaard Acoustical Associates proposal in the amount of \$3,850.00.

Mr. Engelhardt and Ms. Ladd-Kidder spoke in favor of approving the proposal, citing Ostergaard's experience and unbiased expertise.

Mike downing also spoke in favor noting that legislation is circulating at the state level which would not allow municipalities to put restrictions on data centers.

Passed by unanimous vote.

President Snyder noted the following vacancies:

President Snyder asked if there was anyone who wished to address Council before Proceeding with the agenda.

Robyn Reinisch, from 733 Seem Drive, stated that she never had a water problem on her property until her neighbor blocked the water flow with rocks. She asked the Borough to enforce the matter and not allow him to put rocks in the swale.

Mr. Mooney explained that he and the Borough's Code Enforcement Officer visited the property and filed a violation notice. He said there will be a hearing, but enforcement cannot be carried out without a court order, even though he is in violation. He also noted that the neighbor filed an appeal, and the only thing Council could do is send him another letter if they choose.

Mr. Engelhardt said that because it is a repeated pattern, the Borough should issue documentation for the additional violation.

Mr. Mooney told him that he is in violation of the Stormwater Development Plan.

He also explained that he can search for an easement agreement on the Stormwater

Management Agreement with the developer to allow the Borough to go on the property

and correct it at the Borough's expense.

A motion was made by Mr. Engelhardt, seconded by Ms. Ladd-Kidder, Resolved, To direct the Borough's Code Enforcement Officer to visit the property and document additional violations, and to have Mr. Mooney search for the easement agreement on the Stormwater Management Agreement with the developer. Passed by unanimous vote.

Mike Shaw questioned the Planning Commission description on the Borough's Web site, and he asked if you need to be a resident to serve, and if there are any current Planning Commissioners who are non-residents.

Mr. Mooney responded that you must be a resident to serve and that there are no non-residents on the Planning Commission.

A motion was made by Mr. Seyler, seconded by Mr. Kusterer, Resolved, To approve the Consent Agenda, consisting of the following items:

- Review and accept the Minutes of the August 19, 2025, Borough Council meeting.
- Review and accept the Borough Community Development Report for August 2025.

Under Borough Planning Commission, regarding the proposed Ordinance amending the Code of the Borough of Kutztown to include a new Chapter 180, entitled "STR Registration"; establishing regulations for; obtaining a STR operating license, a STR occupancy permit and setting penalties for failure to comply with this Chapter, Bob Weller stated that Ms. Ladd-Kidder found some errors that need to be corrected.

Mr. Mooney explained that he does not think that a companion amendment was taken into consideration during the revisions of this Ordinance, and it will also need to be amended before moving forward.

Mr. Seyler suggested sending the Ordinance back to the Planning Commission; to have Mr. Mooney review the revisions; and to direct him to send the companion amendment to the County. It was the consensus of Council to do so.

Under Environmental Advisory Commission, there was nothing to report.

Under Community Development and Public Safety Committee, the Monthly Police Report for August 2025 was submitted.

A motion was made by Mr. Kusterer, seconded by Dr. Mace, Resolved, to approve a \$500.00 donation to Crime Alert Berks County. Passed by unanimous vote.

Mr. Engelhardt gave a presentation regarding the Action Track USA/Kutztown Fairgrounds Association event on September 7, 2025. He noted that he presented this to the Community Development and Public Safety Committee, but he wanted all of Council to see it. The presentation showed pictures of immense amounts of dust created by the races.

Ms. Ladd-Kidder asked if the track was watered two days before the event, and Mr. Engelhardt said that to his knowledge, it was watered a few hours before the event.

Mr. Seyler noted that the Borough cited Action Track USA and the Fair Board for violation of the Borough's Air Pollution Ordinance.

Mr. Engelhardt opined that the Borough should uphold and fight any appeals.

A motion was made by Mr. Kusterer, seconded by Mr. Engelhardt, Resolved, to direct Keith Mooney to attend and represent the Borough of Kutztown at any related magistrate hearing(s) if the defendant(s) appeal their citations, in addition to the Borough Code Officer. Passed by unanimous vote.

Julie Stark asked if the citation was for dust or for dust and noise, and Mr.

Engelhardt responded that it was just for dust because we do not have a Noise Ordinance.

Ms. Stark noted that it is "unbearable" to be outside, during the races, and that you can hear it inside, too.

Dr. Mace asked what the maximum fine is for the violation, and Chief Clery responded that it is a sliding fee from \$100.00 to \$2,500.00, and the judge decides the fine amount.

Mr. Engelhardt and Mayor Schlegel asked if anyone could attend the hearing, and Mr. Mooney responded that anyone could attend, but the Borough needs people with photos and videos to go. Chief Clery said there will be a subpoena list.

Under Public Works Committee, a motion was made by Mr. Seyler, seconded by Dr. Mace, Resolved, to approve having the Borough's Trick-or-Treat Night on October 31, 2025, from 6:00 p.m. until 8:00 p.m. Passed by unanimous vote.
