Passed by unanimous vote.

A motion was made by Mr. Kusterer, seconded by Ms. Ladd-Kidder, Resolved,

To authorize advertisement of the proposed Ordinance for the prevention and control of

air pollution: defining certain terms used herein; providing for regulations, abatement,

exceptions, enforcement orders, responsibility of owners and operators, penalties,

unlawful conduct, public nuisances.

When President Snyder called for the question, Mr. Mooney noted that changes were made to the Ordinance that should not necessarily have been made, and the above motion died for lack of a vote.

Ms. Ladd-Kidder suggested tabling the motion.

Mr. Khalife said that Council could still authorize advertisement, but they must agree to the changes prior to the advertisement being placed.

A motion was made by Ms. Ladd-Kidder, seconded by Mr. Mace, Resolved, To authorize advertisement of the proposed Ordinance for the prevention and control of air pollution: defining certain terms used herein; providing for regulations, abatement, exceptions, enforcement orders, responsibility of owners and operators, penalties, unlawful conduct, public nuisances; and to remove Section 168-21 (A), and to re-letter Section 168-21, before having the advertisement published.

Under Public Works Committee, a motion was made by Mr. Seyler, seconded by Mr. Mace, Resolved, To approve the 2022 refuse and recycling schedule; to continue with whole town recycling every week in 2022; to have Kutztown University perform an optimization study on our recycling collection; and to send out a recycling education letter with the 2022 refuse and recycling schedule. Passed by unanimous vote.

A motion was made by Mr. Seyler, seconded by Ms. Ladd-Kidder, Resolved, To approve the Rotary Club to use the Park, on June 11, 2022, for the Taste of Kutztown event. Passed by unanimous vote.

Council members noted that glass, particularly in the sandbox area, has been a

problem. Rotary members acknowledged that they are aware of it and will try to come up with a solution for next year's event.

A motion was made by Ms. Ladd-Kidder, seconded by Mr. Seyler, Resolved, To approve a new entrance sign for the Park welcoming people to Veterans Way, contingent upon Council seeing a drawing first. Passed by unanimous vote.

A motion was made by Mr. Seyler, seconded by Ms. Ladd-Kidder, Resolved, To enter into an agreement with the Delaware County Solid Waste Authority for refuse disposal. Passed by unanimous vote.

A motion was made by Mr. Seyler, seconded by Mr. Kusterer, Resolved, To approve the parade permit application for Christmas in Kutztown. Passed by unanimous vote.

A motion was made by Mr. Seyler, seconded by Ms. Ladd-Kidder, Resolved, To refund \$22.50, for one dumpster tipping, at 41 Normal Avenue. Passed by unanimous vote.

A motion was made by Mr. Seyler, seconded by Mr. Kusterer, Resolved, To enter into a Master Service Agreement with Flagger Force Traffic Control Services. Passed by unanimous vote.

Under Personnel Committee, a motion was made by Ms. Ladd-Kidder, seconded by Mr. Kusterer, Resolved, To ratify the hiring of Paul Dalickas, as a Public Works Laborer I (without CDL), effective October 28, 2021. Passed by unanimous vote.

A motion was made by Mr. Seyler, seconded by Mr. Mace, Resolved, To reappoint the following individuals as members of the Police Pension Advisory Committee, whose terms shall expire on December 1, 2023: P. Michael Clery, Jeffrey

DeTurk and Gabriel Khalife. Passed by unanimous vote.

A motion was made by Mr. Seyler, seconded by Mr. Kusterer, Resolved, To reappoint Donald Sechler, as a member of the Kutztown Municipal Authority, whose term shall expire on December 1, 2026. Passed by unanimous vote.

A motion was made by Mr. Seyler, seconded by Mr. Kusterer, Resolved, To reappoint Enos Bleiler, as a member of the Kutztown Transportation Authority, whose term shall expire on December 1, 2026. Passed by unanimous vote.

A motion was made by Mr. Seyler, seconded by Mr. Kusterer, Resolved, To reappoint John Fry, as a member of the Housing License Appeals Board, whose term shall expire on December 1, 2022. Passed by unanimous vote.

A motion was made by Mr. Seyler, seconded by Mr. Kusterer, Resolved, To appoint Randy Marsteller, as a member of the Borough Planning Commission, whose term shall expire on December 1, 2025. Passed by unanimous vote.

An Executive Session to discuss the matter of Duke Realty litigation and nonuniform union negotiations was deferred until the end of the meeting.

Under Finance and Electric Committee, Mr. Khalife introduced and reviewed the proposed budget for 2022.

A motion was made by Mr. Mace, seconded by Mr. Seyler, Resolved, To authorize advertisement that the proposed budget for 2022 is available for public inspection. Passed by unanimous vote.

A motion was made by Mr. Mace, seconded by Mr. Seyler, Resolved, To introduce and authorize advertisement of the proposed Ordinance to adopt the 2022 real estate tax rates. Passed by unanimous vote.

A motion was made by Mr. Mace, seconded by Mr. Seyler, Resolved, To accept the AMP/NextEra Capacity Plan and to enter into an agreement with AMP/NextEra. Passed by unanimous vote.

Under Telecommunications and Information Technologies Committee, there was nothing to report.

Under Water and Wastewater Committee, a motion was made by Mr. Seyler, seconded by Mr. Mace, Resolved, To introduce and authorize advertisement of the proposed Resolution amending water rates. Passed by unanimous vote.

A motion was made by Mr. Seyler, seconded by Mr. Kusterer, Resolved, To introduce and authorize advertisement of the proposed Resolution amending sewer rates. Passed by unanimous vote.

Mr. Seyler noted that the increases are due to regulations, fees and unfunded mandates.

A motion was made by Mr. Seyler, seconded by Mr. Mace, Resolved, To approve payment application #4 from DESCCO, in the amount of \$31,565.48, for work completed on the Briar Cliff and College Garden Drive pump station projects. Passed by unanimous vote.

Under Miscellaneous, President Snyder called for an Executive Session at 8:15 p.m. to discuss the matter of Duke Realty litigation and non-uniform union negotiations. The Executive Session ended, and the meeting reconvened at 8:35 p.m.

A motion was made by Mr. Seyler, seconded by Ms. Ladd-Kidder, Resolved, To approve the terms of agreement with the labor union. Passed by unanimous vote.

A motion was made by Mr. Seyler, seconded by Mr. Kusterer, Resolved, To

adjourn the Council meeting upon vote. Passed by unanimous vote. The meeting ended at

8:36 p.m.
