Borough of Kutztown Planning Commission Minutes of October 14, 2024

A regular meeting of the Planning Commission was held on Monday, October 14, 2024, in the Kutztown Borough Municipal Building Multi-Purpose Room.

The meeting was called to order at 7:00 p.m. by Mr. Robert Weller, Chairperson. Also present were Ms. Shelley Grim and Mr. Josh Young, both from the Community Development Office (CDO).

PUBLIC COMMENTS ON NON-AGENDA ITEMS - No comments.

APPROVAL OF MINUTES

Commissioners reviewed the minutes (as amended) from the Planning Commission meeting on September 9, 2024. A motion to approve the minutes was made by Ms. Bosler & seconded by Mr. Seidel. The motion passed by unanimous vote.

REPORTS

The Commissioners discussed the CDO report from Shelley Grim (see her email dated 10 Oct 2024).

- There were 2 new zoning applications received for September.
 - o 213 W. Main art gallery & living space denied no ZHB application yet.
 - o 312-314 W. Main temporary Democratic Club approved.
- There were 3 DCRs and 3 complaints received for the month.
- The Housing License Appeal Board (HLAB) hearing was held on 18 Sep 2024 for the property at 164-168 W. Main Street. The owner is requesting an exception to the requirement for the owner/agent to reside or have an office within 5 miles of the property. Denied.
- McDonalds (601 E. Main St.) submitted a second ZHB application based on new drawings and building orientation using BOTH lots (i.e., Kutztown AND Maxatawny) requesting relief for four (4) variances related to impervious coverage, parking spaces & signage.
 - ZHB is scheduled for 26 Nov 2024.

OLD BUSINESS/UPDATES

Short Term Rentals (STR) Ordinance

- The Planning Commission Workshop was held on 26 Aug to review the DRAFT STR ordinance. Recommended changes were provided.
- We are still awaiting a response to the recommendations.

Follow-up on Trash Receptacles for Main Street - by Ms. Bosler

- Ms. Bosler met with Brian Bailey (Director of Public Works for the Borough of Kutztown) on Friday, 13 Sep 2024 to discuss the quantity and locations for the additional trash receptacles.
- Ms. Bosler presented a map that showed the location of existing trash receptacles AND proposed locations for new trash receptacles.
- Next step is to contact property owners to determine if they are agreeable to "hosting" the proposed locations.
- Public Works made the following recommendations:
 - o Top-opening receptacles with no locks.
 - o Phased implementation.
- Commissioners suggested adding "pizza box" receptacles to the mix.
